#### **OLD BUSINESS AND INFORMATION**

- Lisa presented the Board with a new fee schedule form, to be used at meetings, when monies is taken and then given to Cathy Leonard for deposit. Pam states that the form submitted needs to be reviewed and adjusted to reflect additional information as fees are taken. Pam tabled it for now.
- The Board discussed Berniers sign at 181 West State Street. Laura Gaj, previous Planning Board member, and chairperson at the time or review, stated that she remembers one sign. The sign that Pam Desjardins shows Mrs. Gaj, is from New England Signs, Inc. and is a 4 ft x 8 ft sign on a 6 ft post. Mrs. Gaj states that the other sign that is digital was never brought in front of the Planning Board back in 2006, and is not the sign that the Board approved.

Pam Desjardins stated that the sign the Berniers has up now, does not comply with our sign by-laws back in 2006 nor does it comply with the new by-laws that is to be propose.

**A motion** was made by Jim Trompke that we send a letter telling the Berniers that their sign does not comply with the Planning Board by-laws and the bottom half, the digital part must come down. **Seconded by** Kevin Brooks. **Motion** passed 3 in favor; 0 opposed; 1 abstained.

After further discussion, Jim Trompke **rescinded** his original motion and wants to table any decision until the Board gets further information. **Seconded** by Kevin Brooks. **Motion** passed 3 in favor, 0 opposed, 1 abstained.

• The Board reviewed the changes to the maps from Larry Smith, PVPC, that we changed from the Public Hearing. Zone 1 map and Zone 3 map.

**A Motion** was made by Jim Trompke to accept the map of Zone 1, as changed. **Seconded by** Kevin Brooks. Motion passed 4 in favor; 0 opposed; 0 abstained.

**A Motion** was made by Jim Trompke to accept the map of Zone 3, as changed. **Seconded by** Lisa Anderson. Motion passed 4 in favor; 0 opposed; 0 abstained.

**A Motion** was made by Jim Trompke to accept the changes we made to the Village Common, adding a theater and funeral home. Also private garages. **Seconded by** Lisa Anderson. Motion passed 4 in favor; 0 opposed; 0 abstained.
