Pursuant to Massachusetts General Laws, chapter 54, section 6, the Town of Granby has changed voting precincts to reflect population changes as calculated by the most recent federal census. Effective December 31, 2011, there will be two voting precincts the polling location will remain at the East Meadow\_School in the cafeteria for both precincts.

The polls opened at 7:00 A.M. and closed at 8:00 P.M. There were 421 Democrats, 146 Republicans, making that a total of 567 voters who came out to support their candidates in this State Primary. That's approximately 13% of our registered voters.

Out of the 567 voters that participated in this Primary 43 of these ballots were processed as absentee ballots and there were no provisional ballots filed.

As of September 9, 2014, Granby had 4,347 registered voters this amount includes 263 inactive voters. As of September 9, the town had 1,501 registered in the Democratic Party, 652 in the Republican Party and, 2,620 as Unenrolled (Independent). We also have 24 registered voters registered in various political designations. Those voters registered in a political designation are not permitted to vote in any Primaries, however are allowed to participate in all other elections.

I certify that all ballots cast for candidates in the State Primary held on Tuesday, September 09, 2014, have been counted and recorded in accordance with the law.
