

## EXECUTIVE SUMMARY


**TITLE:** Appointment to the GB Technology Committee and Delegate to the Wired West Board of Directors.

**BACKGROUND:** When the State legislature and Governor Patrick established the Massachusetts Broadband Institute (MBI), the GB Technology Committee was created to take the challenge and bring broadband access to Western Massachusetts. Bob O'Haver was appointed as the Town's Delegate. Mr. O'Haver has since resigned and there exists a vacancy. The Town is in need of a representative to serve on the GB Technology Committee and as a Delegate to the Wired West Board of Directors. Stephen Kress Bohrer has applied. The term of this appointment is indefinite.
