A. GENERAL COMMENTS BY THE BOARD - None

4. TOWN MANAGER'S REPORT:

A. FOLLOW UP ITEMS

Jennifer Tabakin announced that there will be a Main Street Reconstruction Workshop on March 31st. It will be sponsored by Lee Bank and the Chamber of Commerce. The workshop will be held at the Congregational Church at 5:00 PM.

Jennifer stated that on March 12, 2014, the Massachusetts Historic Commission will be considering including Ramsdell Library on the list of National Register of Historic Places. This may provide historic tax credits in the future.

Jennifer announced that a State Grant was received to hire a consultant to work with local businesses to develop a plan for a BID.

The town webpage is an ongoing project. Jennifer said there is a working list of items to be updated. Deb Phillips suggested that there be a link on the webpage to Great Barrington Trails and Greenways, which includes family-friendly activities in the area.

Senator Downing and Representative Pignatelli have been invited to the next Selectboard meeting. Jennifer said that this will be a great opportunity to talk about various topics including the state budget.

Jennifer gave out information that she received at the Legislative breakfast that she attended. She stated that there was discussion about the potential increase to Chapter 90 funds.

B. DEPARTMENT UPDATES:

- ENERGY COMMITTEE - UPDATE ON GREEN COMMUNITIES PROGRESS

Chris Vlcek and Alana Chernila spoke on behalf of the Energy Committee.

Chris spoke about the Green Communities process, saying that \$142,700 was awarded in 2012 to put in energy measures. He reported that their financial projections were not sufficient enough to allow for the release of funds.

An energy consultant group has become involved to help in the process.

Alana Chernila expressed the importance of having a member of the Selectboard on the committee. She feels that there has been a lack of follow through and reminded the Selectboard that this was established as a priority.

Jennifer Tabakin ensured her continued support going forward.

- TAX LIEN AUCTION PROCESS AND SCHEDULE - UPDATE
