9. SPECIAL GUESTS:

Sen. Ben Downing and Rep. Smitty Pignatelli Updates*

Rep. Pignatelli reported that the budget will be made public on 4/9/14. Local Aid numbers are out and are better than last year.

Andrew Blechman asked what the CPA match will be.

Rep. Pignatelli responded that there is an 85% match. He does not know what the match for 2015 will be.

Deb Phillips said that the local option taxes are low. There are discussions about having a local option gas tax. She asked if there are any other local options to consider.

Senator Downing said that he would be fine with filing the local option gas tax.

There was discussion about Chapter 90 funds.

Deb Phillips asked that the money be released so that it coordinates with construction season. Senator Downing agreed.

Jennifer Tabakin spoke about prevailing wage restrictions. She said that some jobs could benefit local firms. She asked for any ideas as to how to do this.

Rep. Pignatelli suggested raising the threshold; utilize for bigger projects, not just small projects. Senator Downing said that specific ideas would be appreciated including examples of specific projects going out to bid.

Redevelopment was discussed.

Senator Downing was asked for ways to engage with the state to bring development to the mill area. He replied that the State will be very responsive if presented with a plan. He also suggested looking into Mass. Works grants.

Karen Smith asked how they both feel about requesting additional funds for CPA. Senator Downing said that they both support it and will push for including it in the final budget.

There was discussion about school choice tuition and reimbursement.

Rep. Pignatelli said that he will keep raising awareness about this topic. He stated that it is a cost to have 'choice.'

Steve Bannon said that we pay to bus to the private school and still do not receive 100% reimbursement. Senator Downing responded that there hasn't been much conversation about the formula since the 1990's. A commission was just created to start this discussion.

Dan Bailly asked if there was a bid for the Main Street Reconstruction project.

Jennifer Tabakin reported that a contractor was preliminarily chosen. The final decision should be made very soon.
