D. EXECUTIVE SUMMARY SUPPORTING GREAT BARRINGTON HOUSING AUTHORITY RE: GOVERNOR'S LEGISLATION TO ABOLISH LOCAL HOUSING AUTHORITIES. (DISCUSSION/VOTE)

Sean Stanton said that he contacted the Governors office to get his side of the story and was told that he would get a call back. Sean said that he is not ready to move ahead until then.

Deborah Salem – Great Barrington Housing Authority – said that the Governor appointed a commission who came up with a plan which is now being dismissed. Deborah said that the Great Barrington Housing Authority covers all of its operating expenses and runs very efficiently.

Sean Stanton said that he will also speak to Barbara Heaphy, Executive Director of the Housing Authority.

F. FOOD TRUCK DRAFT BYLAW. (DISCUSSION/VOTE)

There was discussion about the draft bylaw.

Steve Bannon questioned the amount of space needed for the truck.

It was also pointed out that the bylaw is not clear when it speaks about food trucks in front of a restaurant. (Can someone else's food truck be in front of your restaurant?)

Sean Stanton said that this is not ready for the warrant for Town Meeting.

Andrew Blechman said there was discussion in the past about having food trucks outside the business district.

Kevin O'Donnell responded that this would require a zoning change.

Mark Pruhenski said that this bylaw is a result of a policy decision to have food trucks on a regular basis. It was drafted to help protect businesses downtown.

Alana Chernila urged the Selectboard to be thoughtful about the concern that it may take away restaurant business. She said that food trucks tend to bring people out, fosters creativity and starts conversations about food. Alana said that food trucks downtown, done effectively, could have a positive impact on businesses.

Deb Phillips suggested a map with lines drawn as to where the trucks can be. She also asked how many parking spots would be lost.

Sean Stanton asked Mark Pruhenski to follow up on these items.

G. BOS - REVIEW 2013 ANNUAL TOWN MEETING WARRANT ARTICLES.

It was agreed to delete Article 18 and Article 20

B. ANN CONDON/CASTLE HILL TRAFFIC CITIZENS GROUP – TRAFFIC UPDATE AND REQUEST FOR PLACEMENT OF SPEED HUMPS. (DISCUSSION/VOTE)

John Horton read a letter from a traffic citizens group who request 4 speed 'humps' and one stop sign at Hollenbeck and Castle Hill. A cost estimate was given for removable speed 'humps'.

Alana Chernila said if there is consideration for these speed 'humps' then they should look at all residential areas in Great Barrington and Housatonic.

Joe Sokul said that traffic counts are beginning to be compiled from this and other areas. Joe said that this data is needed to support this type of decision.

John Horton responded that the perception is that there is a lot of speeding in this area where there are also a lot of children. These things need to be considered along with the traffic count.

Dan Bailly compared the cost of speed 'humps' to the cost of filling pot holes. If speed 'humps' are added, money may have to be shifted from road maintenance to speed 'humps.'

Michele Loubert said that there are no sidewalks in Housatonic. She recently wrote a letter to Chief Walsh regarding the excessive speeding on Route 183 and Van Deusenville Rd. She thanked the Chief for acknowledging her letter and asked that a traffic count be done in these areas.

C. DRAFT RESOLUTION CREATING A COMMITTEE ON GUN SAFETY - DISCUSSION.

Deb Phillips questioned the term 'gun safety' saying that it feels too confined.

Alana Chernila said this was a conscious decision on her part; gun safety is something that we can all get behind.

Sean Stanton added "ad hoc."

The first to lines beginning with 'whereas' were removed.

The word 'such' in the 3rd section was removed.

Sean Stanton read the draft resolution.
