A. GENERAL COMMENTS BY THE BOARD,

Dan Bailly thanked the Great Barrington Fire Department and the Chamber of Commerce for their events: car show and summerfest this past week; it was a great time for residents and non-residents.

Andrew Blechman thanked the Berkshire Record for not using the term 'armed guard,' Andrew said that free digital adapters are available if you ask Time Warner now until September 23rd; for when local cable goes digital.

B. DISCUSSION OF UPCOMING MEETING CALENDAR.

The calendar was presented to the Selectboard for their review.

4. TOWN MANAGER'S REPORT:

A. FOLLOW UP ITEMS

Jennifer Tabakin is working on easements that are needed for the Main Street Reconstruction project. She said that it is very favorable to the property owners.

Jennifer showed the layout for the parking spaces that will be painted at the Housie Dome. There are two options that were presented to the Selectboard. Jennifer will e-mail this layout to the Selectboard for their comments.

Jennifer reported that a Broadband connection was made at Main Street, hence the work in the road. Going forward there will be protocol in regards to communication about permitted work.

B. DEPARTMENT UPDATES

Chris Rembold reported that the final Master Plan draft is available on the town website, at the library, in the Town Clerk's office, etc.

There will be a Planning Board meeting on September 26th to approve the plan. This reflects 3 years of input. Chris thanked the Master Plan Committee, Bud Atwood and Deb Phillips for their hard work on this.

C. COMMITTEE UPDATES

Jennifer Tabakin said that there will be a meet and greet with Chairs of the Town's Board/Committees/Commissions on September 11th.

On September 30th, the Parking Task Force will reconvene.
