Explanation of Project

Chris Rembold handed out an informational page to those present.

He explained that the CDBG grant funds will be used to construct storm water infrastructure in Housatonic and to continue the housing rehabilitation project.

Chris explained that \$913,000 will be applied for by our town alone; \$600,000 will be used for storm water drainage work on Front Street between Main and Pleasant. This will be done to address the flooding problem.

Chris Rembold introduced Patricia Mullins who helped to write and administer the grant.

Ms. Mullins explained that BRPC has worked with municipalities in the past and, as administrators of the grant, they are the line of communication between the town and state agency.

Dan Bailly asked if someone can apply for grant funds a second time.

Pat replied that this is possible and they would not have to go through the entire process again.

## 6. TOWN MANAGER'S REPORT:

Jennifer Tabakin reported that our Chapter 90 money has increased. The new Governor released the fully allocated money for Chapter 90. The FY2015 money will increase from \$419,000 to \$628,000. The next step will be to decide what the priority will be in regards to road work. We can then choose to decrease the borrowing that was needed to supplement Chapter 90 money.

Jennifer reported that the Building Department 's online building permits system is up and running.

Jennifer congratulated Ellie Smith who has worked for the town for over 10 years and is now retiring. She said that she is grateful for her hard work. Ellie will be missed.

Jennifer welcomed new employees, Karen Joe Sicotte, Animal Control Officer, and Heath Agent, Jayne Smith.

Jennifer said that the Housatonic School has brought some interest. She will give a report about this at the next meeting.
