#### 7. OLD BUSINESS:

A. Winter Parking Ban – Discussion.

Joe Sokul spoke to the executive summary that was submitted to the Selectboard.

He also reviewed the current code.

Joe said that surrounding towns have similar bans.

The Police Department supports the ban, as well.

Jennifer Tabakin said that the police department reported in the most recent inclement weather event, 5 cars had to be towed, which took 3 hours.

Joe Sokul said that he feels the process works the way that it is.

B. SB – <u>Continuation</u> of Recommendation to the ZBA on the Comprehensive Permit Application for "100 Bridge Street" submitted by Community Development Corporation of South Berkshire at 100 Bridge Street (the former New England Log Homes property), Great Barrington, MA. (Discussion/Vote)

Tim Geller briefly explained the B3 zoning.

Tim said that this project speaks to economic development, affordable housing and a wide income spectrum living in a common space. This is 8 acres of space with 4 uses.

Larry Boudreaux spoke about how to contain construction in each section.

Ed Abrahams said that the affordable housing part needs to go through but asked that the common area be thought out. He feels that an area only visible to tenants could be unsafe. Ed also said that some buildings are not aesthetically pleasing.

Steve Bannon asked if the buildings could look similar; not a different design so to make the affordable housing portion obvious.

Tim Geller said that they won't be obvious and that this is a work in progress.

Tim presented the results of the traffic study. Pedestrian counts were also done.

Steve Bannon questioned the angle parking.

A stop sign was recommended to be put on Bentley and Humphrey.

**MOTION**: Dan Bailly to issue a positive recommendation for "100 Bridge Street" to the ZBA with the following conditions:

- Look at the possibility of securing a locally/regionally owned anchor business.
- Ensure visibility, safety, accessibility and cleanliness of the common area.
- Fits in aesthetically with the character of the neighborhood.
- Ensure clean utility corridors during construction
- Commercial phase reviews by Selectboard before final plan.
- ZBA to review all final permit plans before they are issued.
- ZBA to consider alternatives to angled parking on Bridge St. based on the traffic study conclusions.
- That the buildings have a similar look and feel (Market rate and affordable housing).
