1. CALL TO ORDER.

Chairman, Sean Stanton, called the meeting to order at 7:00 PM.

2. SELECTBOARD'S ANNOUNCEMENTS/STATEMENTS:

A. GENERAL COMMENTS BY THE BOARD - none

B. SB – VOTE TO AUTHORIZE THE INTERIM LOAN FROM THE MASSACHUSETTS WATER POLLUTION ABATEMENT TRUST FOR PHASE 1 OF THE SEWER IMPROVEMENT PROJECT IN AN AMOUNT WHICH IS NOT TO EXCEED \$4,210,000.

MOTION: Steve Bannon:

- (1) That the Town shall issue a bond or bonds in an aggregate principal amount not to exceed \$4,210,000 (the "Bonds") pursuant to Chapters 29C and 44 of the General Laws and a vote of the Town passed May 7, 2012 (Article 9), which authorized a total borrowing of \$4,500,000 for the construction of sewers and other water pollution control facilities identified in such votes (the "Project");
- that in anticipation of the issuance of the Bonds, the Treasurer is authorized to issue an interim loan note or notes (the "Notes") from time to time in an aggregate principal amount not to exceed \$4,210,000;
- (3) that each Bond or Note shall be issued as a single registered security, and sold to the Massachusetts Clean Water Trust (the "Trust") at a price determined pursuant to the Financing Agreement;
- (4) that the Treasurer is authorized to determine the date, the form, the maximum interest rate and the principal maturities of each Bond and Note, and to execute a Financing Agreement (or Agreements) with the Trust with respect to the sale of the Bonds and Notes, such date, form and maturities and the specific interest rate or rates of the Bonds and Notes to be approved by a majority of the Selectboard and the Treasurer and evidenced by their execution of the Bonds or Notes;
- (5) that all action taken to date by the Town and its officers and agents to carry out the Project and its financing, including the execution of any loan commitment or agreement by the Treasurer, are hereby ratified, approved and confirmed; and
- (6) that the Treasurer and the other appropriate Town officials are each hereby authorized to take any and all actions necessary or convenient to carry out the

provisions of this vote, including execution and delivery of the Financing Agreement(s) and the Project Regulatory Agreement(s) relating to the Project.

Jennifer Tabakin clarified that the Selectboard will sign the papers after the meeting.

3. TOWN MANAGER'S REPORT:

Jennifer Tabakin reported that the town has been awarded \$842,569 from the Massachusetts Community Block Grant program. There are two parts to this program; the drainage project in Housatonic and the continuation of the Housatonic Housing Rehabilitation project.

Joel Malonzy said that he was impressed with the discussion at the Finance meeting, but walked away from the meeting feeling that the town is frustrated that they are being unfairly burdened due to the school district.

Sean Stanton said that there is a process to look at the School District Budget and encouraged people to be a part of it.

Alana Chernila asked for a re-assessment of the Energy Committee. She reported that they have lost members and are so small that they don't have a quorum.

Alana said that the committee feels that they have fulfilled the mission.

Brandee Nelson asked that the committee be reduced to 5 members so they can have a quorum to approve the minutes.

Brandee Nelson said that she would love to see the Selectboard in a liaison role with the Committee; a goal can then be determined. Brandee said that the Committee needs leadership.

Sean Stanton said that he will meet with them to discuss what the future of the Energy Committee is. Alana Chernila said that the Green Communities Grant continues so the administrative side of this process needs attention.

B. SB – RECOMMENDATION TO ZBA ON THE SPECIAL PERMIT APPLICATION OF JOHN TRACY/LINDA HODDY'S APPLICATION TO CONSTRUCT A DECK ON A PRE-EXISTING, NON-CONFORMING HOUSE AT 224 NORTH PLAIN ROAD. (DISCUSSION/VOTE)

Diego Gutierrez presented this project. He explained that the property is within 50 feet of the setback. The deck will be elevated on posts.

C. SB – RECOMMENDATION TO ZBA ON THE SPECIAL PERMIT APPLICATION OF KSNS STOCKBRIDGE ROAD REALTY TRUST TO ADD A THIRD FLOOR AND 20 GUEST ROOMS TO THE HOLIDAY INN EXPRESS AT 415 STOCKBRIDGE ROAD. THE BUILDING IS LEGALLY PRE-EXISTING, NON-CONFORMING BECAUSE THE BYLAW CHANGED AFTER IT WAS BUILT. (DISCUSSION/VOTE)

Nick Arienti explained the project. He said that this would include the addition of a 3rd floor within the same footprint. He explained that the Holiday Inn gave the owner an ultimatum that it must be a 3 story building or they will pull the franchise. The project must be completed by 2017.

There will be minimal traffic increase as a result of this project. There will be no burden to the existing public utilities.

Ed Abrahams expressed his concern with recommending that the ZBA ignore the current by-law. Nick Arienti said that there are only 3 buildings under this rule in the town. He re-iterated that this will be for existing use; they are not proposing something new.
