4. TOWN MANAGER'S REPORT:

- A. Department Updates
- Housatonic Water Works meeting is Wednesday, September 27, 2017 at 6:00PM. This meeting
 will be held at the Housatonic Community Center and Mr. Mercer will review the recent lead and
 copper results.
- Wednesday, September 27, 2017 at the Mason Library there will be a program offered titled "News Literacy, Who do I Believe." Steve Fox, a journalist will present this program and it will begin at 5:30pm.
- Friday, November 29, 2017 Simon's Rock students will be offering a story time for toddlers from 11:00am- 12:30PM. The students will also provide tech help at the library that afternoon from 1:00-3:30PM as part of their annual community service day.

B. Project Updates

- Municipal Aggregation

Nextera was selected as the best option as electrical supplier. Nextera is 100% wind power with a rate of .105990.

- Downtown Parking

The Town Manager reported that she met with several residents this past week that requested more downtown parking. The concern was raised that there is not enough parking for people that live downtown and what is there has a 4 hour time limit. Ms. Tabakin said that she will be begin to research this demand and report back to the Board in a few weeks on what locations might be doable for long term or additional parking.

- A. To review and receive comments on the implementation of the FY14 CDBG CDF I 00763 Great Barrington Community Development Block Grant, including Front Street Drainage Improvements Construction Project and the Housing Rehabilitation Program. Residents and interested individuals from Great Barrington are encouraged to attend and participate.
 - a. Discussion/Public Comments

Bill Compton, the Senior Planner and representative of the grant administrator reported to the Board on the recent developments of the Community Development Block Grants. The funds were used for a Great Barrington Housing Rehabilitation program that rehabilitated two owner occupied homes and the Front Street drainage project that provided updated drainage to the Monument Mills area in Housatonic Village.

Dan Bailly asked what the number of applicants was for the housing rehabilitation funding. Mr. Compton said that he did not have an exact number but the waiting list has close to 50 homeowners.

Bill Cooke said that the Great Barrington Housing Trust Committee has applied for CPA funding to continue this rehabilitation program. Dan Bailly asked if this grant will be available to Great Barrington in the future. Mr. Compton said that this particular grant has expired but the grant program is available to any community in Massachusetts.

Atty. Laurie Robbins represented the applicant, Timeless Auto Sales, LLC. Atty. Robbins clarified the hours of operation will often oppose the operating hours of The Cove. Timeless Auto Sales will be open 9-5 and the bowling alley will be open in the evening. Ed Abrahams asked if there was parking in the back of the building. There is not an official parking lot in the back of the building but there is the potential for an additional parking lot behind the building. The cars that Timeless Auto will be selling are gently used, high-end European models such as Mercedes, Jaguars, etc. Ed Abrahams asked the owner if there would be the typical flood lighting you see used for dealerships. They said no, the parking lot lighting would not change.

Town Planner Chris Remold described the intention of the boat launch project. Mr. Remold said that the boat launch would essentially remain the same with some minor improvements to the parking area to prevent further erosion of the gravel into the lake. Mass Department of Fish and Game said that the first step in receiving the grant would be to sign a land management agreement. The land management agreement specifies that the Town cannot restrict use of boat launch for out of town residents and if fees were imposed to fairly charge out of town users in proportion to what local users are charged. The Lake Mansfield Task Force endorsed this agreement.
