**WPA NOI 167-0369** from Dave Inglis of Mahaiwe Harvest located on South Main Street, Map 37 Lot 93 for new agriculture in the resource area of the Green River, a NHESP habitat and a 100 year flood plain. **Continued from August 28, 2013.** Update on progress.

**WPA RDA** for Fair Ground Community Redevelopment Corp., Inc., 659 South Main Street Great Barrington; to construct a fenced area of about 250' x 50' near the entrance of the Fairgrounds. **Continued from March 26, 2014.**

**WPA RDA** for Mary Julia Kephart, 15 Seekonk Rd, to remove invasive plants by means of a mini excavator; to be replaced with native plants.

**WPA RDA** for Housatonic Solar 1, LLC, to construct a ground mounted solar array which will include the installation of the solar panels and electrical equipment, trenching and the installation of a fence at 49 Van Deusenville Rd..

**WPA NOI** for Kirt Mayland of Reservoir Holdings LLC, for the construction of a solar energy generating facility at 295 Park Street.

**WPA NOI** for Christopher Nye of Myrin Institute, 187 Main Street for the stabilization of an existing retaining wall, construction of a new retaining structure, elimination of an existing parking area and the creation of a "pocket park" with associated drainage and building improvements.

**WPA NOI** for Edward Domaney, 327 State Rd., to reconstruct an existing stream crossing while maintaining access to the primary residence.
