1. CALL TO ORDER

Jessica Dezieck called the meeting to order at 6:30 P.M.

WPA NOI 167-0369 from Dave Inglis of Mahaiwe Harvest located on South Main Street, Map 37 Lot 93 for new agriculture in the resource area of the Green River, a NHESP habitat and a 100 year flood plain. Continued from August 28, 2013. Update on progress.

Dave Inglis sent a letter stating that he is waiting for financial partnership in order to move forward.

Request for Determination of Applicability from the Great Barrington Land Conservancy for repairs and/ or replacement of boardwalks, viewing deck, and bog bridging in the existing nature trail at the Pfeiffer Arboretum. Property is at 249 Long Pond Road, Map 33 Lot 5A. All work will be confined to the original footprint of the existing structures, no motorized equipment will be used, only hand tools, and only locally sourced rot resistant lumber (locust, tamarack, cedar, or hemlock) will be used. Greenagers and local volunteers will provide the labor with oversight by Christine Ward.

Christine Ward presented on behalf of the RDA. Ward asked the Commission to continue the RDA until November so she can speak with the trail builders to discuss overall cost. The bridge over the bog will be slightly longer, helical piers will be utilized in new addition, and rot resistant boards will be placed over existing piers. Andrew Mankin, if you are okay with removing the old piers, we are okay with you removing and replacing

the piers. Ward, "I will present figures as well as a proposal at the next meeting in November."

Request for Determination of Applicability from the Housatonic Valley Association for periodic cleanup of the Housatonic River in the town stretch from north of Bridge Street down to Brookside Road bridge. Trash will consist mostly of tires found on the bottom of the river and miscellaneous items from the bottom and up the bank. Some volunteers will wade the river. Canoes will transport trash to the Riverwalk access point(s) where it will be sorted and bagged for collection and transport to appropriate disposal sites. The Access sites are at 195 Main Street, Map 14 Lot 225, and canoe launch sites off Riverwalk near the Bridge Street bridge and off Brookside Road near the Brookside Road bridge.

Allison Dickson of HVA, informs the board that the Town is going to take care of the removed trash.

Request for Determination of Applicability from Shep Evans. Property is at 219 Monument Valley Road, Map 36 Lot 4. Proposed work includes demolition and removal of an old deteriorated garage and construction of a new pole barn garage in its place. All work will be in the buffer zone of an intermittent stream. Erosion controls will be installed prior to the start of work and will be monitored and maintained until all disturbed areas have been seeded and stabilized.

Shep Evans, the footprint is going to be different but similar and there will be no disturbance to the intermittent stream.

Notice of Intent (DEP # 167-0406) from Foresight Land Services on behalf of Michele Waldman. Property is located at 42 monument Valley Road, Map 41 Lot 15. The proposed work consists of demolishing an existing single family house; installing a new 16 ft. wide common driveway crossing Muddy Brook via a new concrete deck bridge and continuing uphill to two proposed house sites.

Review of Restoration Planting achievements and replacement planting proposed by Windy Hill Farm to achieve mandated 75% survival of restoration plantings under the terms of the Revised Enforcement Order of 12/18/2013. Properties are located at 263 Long Pond Road and 249 Long Pond Road, Map 33 Lots 3, 4, and 5A.

Dustin Bartlett spoke on behalf of Windy Hill Farm and applicant Lynn Hutchinson. There has been a 64% survivability rate among the original plantings. Lisa Bozzuto, "Sometimes nature does a better job at restoration and that doesn't always happen as fast as we want it too. I think we should focus on creating a healthy habitat." Christine Ward, "I'm concerned about the tree to shrub ratio. I would like to see more taller trees, the impact of the shade from taller trees will decrease the probability of invasive species."

Windy Hill will submit a revised plan.
