1. CALL TO ORDER

Chairman Mankin called the meeting to order at 7:00 P.M.

7:00 pm - SMA NOI 0012 for Eagleton School, 446 Monterey Rd., Great Barrington; for the construction of a water treatment building and holding tank to serve the campus. Shannon Boomsma submitted a plant proposal.

Jessica Dezieck expressed her concern about the invasive control around the cut area.

Shen Evans suggested that the Conservation Commission reserve the right to check in

Shep Evans suggested that the Conservation Commission reserve the right to check in on invasives management.

Shep Evans stated that the OOC will be sent to White Engineering, who will record it.

7:10 pm – WPA NOI 167-0369 from Dave Inglis of Mahaiwe Harvest located on South Main Street, Map 37 Lot 93 for new agriculture in the resource area of the Green River, a NHESP habitat and a 100 year flood plain. Continued from August 28, 2013. Update on progress.

7:20 pm – WPA RDA for Fair Ground Community Redevelopment Corp., Inc., 659 South Main Street Great Barrington; to set grade stakes 20 feet from the wetlands and tie cord or rope and flagging along the stakes from end to end effectively roping off the wetland from public access. There will be the construction of a 40'x80' tent, 112' diameter tent, and 30'x60' tent. Bart Elsbach announced that the circus will be held at the Fairgrounds in July. The tents and all related items will be kept out of the wetland area. A setback will be created, as requested.

Jeff Cohen said that he would like to see how the area will be protected by more than just rope given all of the cars and walkers on the property. He suggested a temporary snow-type fence, plastic fence or the like. Andrew Mankin stated that demarcation should be clear.

Jessica Dezieck suggested a greater distance be put between the people and the wetlands; 50 feet. She also suggested staking off the wetland drainage area which is very muddy.

Andrew Mankin agreed.

Bart Elsbach stated that the entrance and exit will be farther to the east.

MOTION: Jessica Dezieck to issue a Negative #2 for the circus performances and wetland demarcation with some sort of temporary fencing for the dates of July 14 through July 28.

7:30 pm - WPA RDA for Fair Ground Community Redevelopment Corp., Inc., 659 South Main Street Great Barrington; to construct a fenced area of about 250' x 50' near the entrance of the Fairgrounds.

Bart Elsbach proposed a dog park in order to control and contain the location that the dogs go into. Andrew Mankin said that there needs to be proof that this area is not a wetland, hydrologic connection or other condition

Jessica Dezieck suggested a site visit. She is concerned with the parking area.

Bart explained that no one can park or drive in this area.

Andrew Mankin asked that the wetland area be flagged and the dog park staked for a site visit.

He also suggested having a specialist re-delineate the wetlands.

7:35 pm - WPA RDA for Fair Ground Community Redevelopment Corp., Inc., 659 South Main Street Great Barrington; to repair and replace the existing cowshed structure at the site entrance on the same footprint.

Bart Elsbach stated that the cowshed has been deemed not useable. It needs to be taken down and replaced with a structure of similar purpose.

Andrew Mankin said that the Board of Selectmen are required to issue a special permit for work in the flood plane.

David Shanahan said that there would be no negative impact to the area.

Bart said that he is not filing for compensatory credits at this point. He is not changing the use or impacting the area.

Al Thorpe represented Deidre Corcoran. There was a silt fence in place while construction was under way. There are no grading or elevation changes.

 Town Planner, Chris Rembold - Lake Mansfield watershed/stormwater project @Castle Hill Ave.

Chris Rembold gave a detailed presentation about this project. He showed a map of the area before and after the work. Thanks to this project, the water entering the lake will now be 90% cleaner than before. There were many volunteer hours that were donated to help complete this project.

- SMA Cutting violation 166 Castle Hill Avenue, McDonald property Shep Evans said that he has spoken to the owner. A restoration plan will be created.
- BRPC & MACC education opportunity at BRPC, 1 Fenn St., Pittsfield Shep Evans handed out information about this to the Commission. This is a free event.
- Beaver Permit at 54 Hurlburt Road.

Shep Evans showed a map of this area. The dam needs to be removed in order to keep the property from becoming wetlands.

MOTION: Jessica Dezieck to approve the beaver permit with the condition that Shep Evans and David Shanahan meet to discuss.

Other last minute items

Diego Gutierrez spoke about a plan from 1999 in which there was an extension made to a building in White House Square. (Currently where the gym is)

The construction will take place within the original footprint.

Andrew Mankin would like specifics around compensatory storage and a NOI for the project since the original is so old.

Jessica Dezieck said that there may be a certificate of compliance not complete from the original work. There will be follow up to this matter.

Shep Evans reported that the DPW has been storing snow at 'Old Maids.' As the snow melts, it runs down the river bank.

Shep spoke with Joe Sokul who said this is common practice. Shep asked him to move it 200ft away next year. Shep will review the plan before snow season next year.

Shep reported about the Getty Station. Observation wells are being put in and earth samples have been taken. Ground water samples will be taken in the near future.

Jeff Cohen would like to know if this is Phase 1 or 2.

A storm water drainage storm- scepter has been put it. They would like to stop maintaining it. Shep does not agree that this should be left in without maintenance as originally proposed by Getty and would like a plan brought before the Commission.

David Shanahan spoke about street sweepers in parking lots. He would like to bring this up to the Board of Health because they aren't using water in the process.
