Update from Nathan the Intern -

Nathan said that he is working on mapping all paths. He will mark the invasive species on the map, as well.

Amanda Sewall said that mapping has proven to be more important than a written report. This project will be completed by June 1st. Amanda stated that Nathan has a current abutter list. She would like to draft a letter inviting them to a meeting to discuss the property.

David Shanahan said that he would like to take a look to see who the 'culprits' are: 4-wheelers,

horses, etc.

Amanda Sewall suggested that the Commission create a mission statement around the McAllister property. Amanda said that the kiosk placement may be a good place to start communication with postings. She suggested that the kiosk be put through the red gates to the left. (On Hailey Rd.) Jessica Dezieck suggested explaining the rules and regulations of the property to the abutters. She also suggested reading the letter that was written by the person who deeded the property in order to explain their intent.

It was decided that there would be a meeting on June 12 at 7:00 regarding the McAllister property.

Chesloff Res/Birchridge: Per OofC, updated construction plan reflecting built conditions and how site will be finished off.

Craig Okerstrom-Lange presented an updated map. He stated that the buildings are up, the septic system was installed and erosion controls are up. The driveway still needs to be shifted and landscaping will be done at the end of the project.

Andrew Mankin suggested scheduling a site visit.

Amanda Sewall said that she will try to schedule it for May 2nd.

Perkin Res/Birchridge: Per OofC, swimming pool more detailed and adding hot tub at existing terrace just north of house deck. Have Plan by Chris Blair and description. Low profile, 18" above ground at seat height. To be installed amongst landscaping. Craig Okerstrom-Lange presented the plan. He stated that the pool excavation begins next week and erosion control will go in on Monday. He said that the crushed stone will be removed and they will use the terrace that exists. Craig said that he hopes to finish by mid-summer.

ZBA Application – 1 Cypress Street

Amanda Sewall said that the Conservation Commission has no jurisdiction in this matter. The owner wants to build a shed dormer to expand the existing attic space.

MOTION: Jessica Dezieck that the WPA does not apply.

Andrew Mankin requested that a site visit be scheduled.

SECOND: Jennifer Connell

VOTE: 6-0

Andrew Mankin spoke about the site visit on Seekonk Rd. where there is town work going on. He said that they had not restabilized the bank. Andrew said the application was for restoring the road, not the bank. However, in the application process, they are responsible for keeping silt and run-off from going into the river; hence they need to stabilize the bank. They did increase the erosion controls and since the site visit, Joe Sokul said that he would hydro-seed the bank. Jessica Dezieck stated that there is no vegetation; therefore, it will keep happening.

Andrew Mankin said that there will be more projects now that they are entering the Spring/Summer. He suggested assigning certain projects to each member.

Jessica Dezieck said that Lake Mansfield clean-up day is Sunday 4/28 from 10:30 - 3:00. She said there are lots of projects that need attention.

Amanda Sewall said that Chris Rembold sent the final draft of the open space and recreation plan and wants comments by May 20th. She asked that the Commission members send their comments to her by May 15th.
