Lisa Bozzuto inquired about the amount of trees that will be removed. They agreed that each tree removed is replaced with another, 1:1 replanting. The Board decided that White Pine should be the replacement species.

Dennis Downing representing Margaret Brownell and Adam Medina. They agreed that Margaret and Adam can clear all brush that does not exceed a 4" diameter and then Margaret will come back to the Board for a site visit. The Board will then assess how many trees and shrubs can be removed.

• McAllister Reserve- Report of the Ad Hoc Committee and Discussions of Land Use Regulations and Enforcement Issues.

At a recent site visit Andrew M noticed the prevalence of invasive species on the property. He reported that some type of work needs to be done to address this issue or the landscape is going to drastically change in the next 4-8 years. The Board discussed funding options for such a project.

• Larkin enforcement matter. +/- 15.6 Ac. Violation adjacent to Housatonic & Green Rivers.

Natural heritage program sent a letter to Mr. Larkin. There is a suggested solution to remediate the injury to protected habitat.

Moses Clark LLC Enforcement Order issued 8-19-2013.
518 Egremont Rd. A pond was dug with a water source being the Green River. Emily Stockman has called for an inspection on the plantings for the slope.
