Mr. May said there is a proposal for a banner across Main Street for the Mahaiwe Summer Events. The information was presented to make the Committee aware. There was not an application presented.

Mr. May had an application for four signs for Mary Childs Gallery on Railroad Street. The application is for vertical sign to be attached to the brick of the theater building. The sign would be 16" x 9". A sign for the tenant directory would be placed on the current directory board and it would be 16" x 6". A wall sign to be mounted on the catwalk would be 30" x 50". A shingle sign measuring 24" x 52" is the fourth sign.

The Committee was unable to vote on the application for the four signs as the applications did not come in prior to the posting of the agenda. The Committee scheduled a meeting for July 5, 2012 to vote on the proposed signs for Mary Childs Gallery.
