- 1. Call to order: Sean Stanton called the meeting to order at 6:00 P.M.
- 2. FY 14 Budget Policy for Adoption

Kevin O'Donnell stated that the FY 2014 budget policy was sent to all Boards and Committees for their review. The schedule of budget meetings was also presented.

Kevin began the review by saying that 75% of the revenue comes from property tax.

The tax levy will maintain a single rate.

Kevin said that there is \$3.4 million in free cash, some of which may need to be utilized for the Searles-Bryant contamination project and fire department issues.

Joe Sokul said that a level 2 energy audit will be done on all buildings in order to receive the energy grant money.

Sharon Gregory said that it would be helpful if there was a 'fully-loaded' cost of employees included. Sharon would like to see a breakdown with retirement, insurance cost, etc. with a 5, 10 and 20 year cost burden. (See later motion)

Sean Stanton questioned the wording under Fiscal Management where it says "authorize no new program without an identified financing source to pay for said program/staffing." Sean said that there should not be the option to present a new program.

Kevin O'Donnell clarified that a new program can be presented only if a funding source is provided. A new program would not be put into the budget if it is not paid for by a source other than the town.

Sharon said that she would like to see not only a level budget, a budget minus 5% and a budget minus 10%. She requested that the Town Manager to introduce how this can be possible. Sharon said that items should not be delayed and other items paid off, but there should be a real decrease in expenditures.
