APPROVAL OF MINUTES

Daniel Bailly made the motion that the minutes of May 1st 2014 public meeting be approved as written with a second by Barbara Syer. All members present voted in favor.

OLD BUSINESS

Historic Markers were not reviewed or updated.

NEW BUSINESS

Public Hearing - Roof Replacement Manse 241 Main Street

Public Hearing was opened on Roof Shingles Replacement on the Manse at 241 Main Street. Three adjoining roofs on the northerly side off Pleasant Street are proposed to have new Red Shaded Asphalt Shingles installed where existing similar shingles need repair/replacement. Roofs on the Carriage House have Red Slate Shingles which are very costly today. These upper roofs on the residence are less noticeable from the street.

The public hearing was closed. Donald Howe noted that the Building Inspector has determined that Control Construction does not apply to this particular work.

Daniel Bailly made a motion that the work is Appropriate with a second by Pat Ryan. Motion passed by Troiano, Bailly, Ryan and Howe voting in favor and Syer abstained.

Moulding Repair - Manse Porch 241 Main Street

Bird Deterrent - First Congregational Church Steeple 251 Main Street

The Church will be installing stainless steel bird deterrents on the existing steeple roof. The Church property has been subject to a pigeon infestation in the past. Daniel Bailly made a motion that the work is Appropriate with a second by Pat Ryan. Motion passed by Troiano, Bailly, Ryan and Howe voting in favor and Syer abstained.

Donald Howe noted that Chris Skelly of Mass Historical does a seminar on combining Historical committees that could be presented at a Demolition Delay seminar.
