### 1. APPROVAL OF MINUTES:

# 2. **HEALTH AGENT REPORT:**

Mark advised that there was lots of Title 5 activity, septic inspections, two Ebola conferences and some complaints. (A copy of the report is attached to these minutes).

# 3. UNFINISHED BUSINESS:

A. 2014 Flu Clinics – Mark advised the last clinic was on November 4, 2014 during the voting hours. There will be one at Berkshire Meadows for the staff and residents. There were flu clinics also at the Senior Center, Housatonic Community Center as well.

# 4. **NEW BUSINESS:**

- A. Permit Renewals/Application for 2015 Mark advised that the renewal applications have been packaged up and are starting to be returned. He noted there are folders for each category to put the applications in for processing.
- B. FY 16 Budget Draft Mark said the budget draft is usually presented at the December meeting. He noted it is not complete as he is waiting for a quote on the public nurse contact and beach testing amount for next year. Mark advised it would e-mailed to the board members.
- C. Upcoming Transition Process at Health Department. Jennifer Tabakin noted that the Berkshire Public Health Alliance has submitted a proposal to cover inspectional needs. She noted the rate is \$50.00 per hour to perform needed services in Great Barrington and they would bill quarterly. The travel costs from Pittsfield is \$25.00 per hour but they advised they would combine the travel costs with other south county towns to minimize those costs. It was noted that the advertisement for a new health agent needs to stipulate the need for training and certification. Four options were presented and the board after review decided on Option 1. (See attached)

MOTION: Claudia Ryan that the Board of Health appoints Mark Pruhenski as a special agent

on a per diem basis until there is no further need.
