Bid Opening:

- M. Cloutier informs the board that two bids for Wire and Messenger was opened earlier in the day.
- 1st Bid from Arthur J. Hurley Co. \$36,140.00.
- Lower firm pricing on wire.
- 2nd Bid form Hendrix Wire and Cable \$35,809.15.
- Lower on the messenger. 6-8 weeks for delivery.
- M. Cloutier recommend that GELD buy the wire from Arthur J. Hurley and the messenger for Hendrix. It would save GELD \$500.00.
- K. Cross asked where the wire was going to be used.
- M. Cloutier on King Street.
- S. LaBelle makes a motion to buy the wire from Arthur J. Hurley and the messenger from Hendrix.

Power Supply:

• M. Cloutier explains that he is investigating pricing from B.P. but they aren't interested in small utilities. Nextra's married load follow product: we are waiting for them and don't plan on getting them right away. Looking at Con Ed Development and having discussions with Bill MacNamara on a battery for the solar field. GELD could use the battery to offset load reduced cost.

- S. LaBelle asked how this could be environmentally safe.
- M. Cloutier replied by containment.
- S. Labelle asked if anyone else has done this.
- M. Cloutier replied that it has been around awhile. It is the price point. GELD can take
 advantage of price saving compared to declining prices. 100% charge from solar and 30%
 tax credit.

- M. Cloutier mentioned that only fifty percent can be hard topped.
- K. Cross thinks the roof issue at the building should be discussed.
- M. Cloutier asked if the board wanted to keep it separate from the architectural bid.
- K. Cross replied that he didn't know.
- M. Cloutier responded that he will have someone look into it.
