## 944 Salem Street (Unit G):

- M. Cloutier reminds the commissioners that Mr. Tub is going to be misplaced because GLD needs that end of the building they occupy. He reminds them that GLD did mention helping him with the move. He will have to incur the cost of a new showroom. M. Cloutier thought that the remodel is his responsibility but will help with the bathroom and maybe not go up on his rent once he moves and signs a lease. This may help. What do the commissioners think?
- K. Cross asked M. Cloutier to look into if the bathroom has to be handicap because he would like to do it once and that's it.
- S. LaBelle mentions that it has to be compliant.
- M. Cloutier does remind the commissioners that the lease states that any remodels and permits must be the tenants' responsibility. He thinks that we should let him do the build out. It is faster and it will be cheaper and no bidding process.
- K. Cross would like M. Cloutier to run it by Diedre Lawrence.

- S. Daniels sees no problem with this because all tenants are responsible for their own upgrades.
- M. Cloutier mentions that if Mr. Tub doesn't move in than another tenant is asking to be able to rent Unit G. Groveland Auto is interested in this space or he has mentioned that he will have to move out if the unit can't be rented to him.
- K. Cross said that is too bad.
- S. LaBelle replies it is what it is. Mr. Tub has first dibs on this unit if they want it. GLD is making them move.
- K. Cross mention that if Groveland Auto moves than GLD should consider taking over that unit as extra space for the trucks.
- M. Cloutier mentions that if Mr. Tubs is unable to take over Unit G and Groveland Auto takes Unit G. We should amend the lease saying that he doesn't have exclusive rights to that side of the building. It all depends on how much Mr. Tub is willing to spend GLD would have to do what is right for the department.
- S. LaBelle replies we can't use GLD money to build a show room.
