944 Salem Street (Up Date):

- M. Cloutier informed the commissioners about the letter that was sent to Groveland Auto and that M. Cloutier hasn't heard anything.
- M. Cloutier tells the commissioners that (Unit G) was cleaned out from the smoke damage and he was waiting to hear if the insurance company was going to pay for it to be painted.
- Mr. Tub does want to stay but was concerned about having to pay for the remodel. Mr. Tub does know the GELD will help them move.
- Architect will have the early design by next week. The Design should be complete by October and out to bid by November.
- GELD will have three options for the roof:
- Replace it all together, just replace panels or insulate and put down rubber roof. This doesn't have to be decided right away there will be time to decide later.
- M. Cloutier mentions that the sky lights will have to be replaced to be more compliant. Thermal panes and tempered glass. They will also be bubbled.
- M. Cloutier informs the commissioners that the septic is complete. Waiting for one invoice from Cammett Engineering and the sign off from the board of health.

Power Supply:

- M. Cloutier mentions that he still hasn't done anything. The longer we wait the more money we save.
- M. Cloutier passes out graphs to show the commissioners the difference between how last year's power supply is divided up and what next year may look like. He is thinking about buying blocks.
- M. Cloutier has begun to talk with Con Ed Development to discuss buying batteries. Con Ed doesn't think it is viable down the solar field. But another plan maybe to do another

solar field and batteries on the land that we own behind 944 Salem St. M. Cloutier has been talking with Bill MacNamara and GELD may not even do solar. May only do batteries.

- M. Cloutier explains to the commissioners why batteries are so attractive to GELD. Manager's Report:
 - M. Cloutier informs the commissioners that the GELD sent our linemen out on mutual aid on August 4th, 2015. A crew went to Peabody and 1 lineman went to Reading.
 M. Cloutier showed the commissioners a letter from Reading thanking our lineman for the help and outstanding work that was supplied.


June Financials:
