Call to order at 6:36 p.m. by motion from B. Gauvin, seconded by C. Herman. Unanimously voted. Meeting was not recorded.

Budget

- Initial budget approved on 1/25/16 was amended by Interim Director as requested by town's Finance Director.
- Budget proposal was unanimously approved on a motion made by C. Shramko and seconded by L. Thomas.

Minutes

- C. Shramko made the motion, seconded by K. Prunier and it was unanimously voted to accept the Minutes from 1/13/16 meeting.
- K. Prunier made the motion, seconded by C. Shramko and it was unanimously voted to accept the Minutes as amended from 1/25/16 meeting.

MBLC and MVLC update

- The posting of the Interim Director has not yet been removed from the site.
- B. Burton and Haverhill Library Director met with some Haverhill Trustees to
 discuss reciprocity arrangement. A vote will be taken at their next meeting.
 Advocacy by the LAL Trustees to apply for a waiver was recommended. K. Prunier
 suggested LAL create a policy for lending reciprocity as a "good neighbor" gesture.
- J. Voogd drafted a thank you letter to the Trustees of Manchester-by-the -Sea and Hamilton-Wenham Libraries for presently continuing to lend to us.

Director's Report (see attached)

- K. Prunier made the motion, seconded by C. Shramko and unanimously voted to spend \$150 from the Donation account for the June "Swinging Our way to Victory" program.
- LAL has been approved to receive a \$1200 grant from the Groveland Cultural Council for a program "Candlelight in the Fall".

Treasurer's Report

- Former Treasurer Laurie LeBlanc's name has been removed from LAL bank accounts.
- All monies have been consolidated into one checking account at Citizens Bank.

Consortium Reciprocal Library Services Situation

The moratorium on reciprocal services has gone into effect as anticipated. Hamilton-Wenham and Manchester are the only MVLC members who continue to extend reciprocal services. The Hamilton-Wenham trustees will be meeting next week and will likely vote on whether to maintain this status.

There have been a few Groveland patrons who have voiced concern about not being able to borrow from other libraries, and a few patrons of other libraries (mostly Haverhill) voicing concern at not being able to borrow materials from here. It will be another month at least before the circulation statistics reflect the changes.

One of the approaches we have taken during this non-certified period is that of adding a patron-driven element to our collection development. Purchasing items that Groveland patrons might otherwise have borrowed from other libraries is having the benefit of engaging Groveland patrons in a primary aspect of their library, and as the months go by, the collection as a whole will be more reflective of the interests of Groveland residents.

After declining circulation statistics in November (3540) and December (3290), in January, 3691 items circulated. However, by comparison, in January of 2015, 4537 items circulated, and in January 2014, 5628 items circulated. Nearly all MVLC member libraries are experiencing a similar overall decline in circ numbers over the past two years.
