Natural Hazards Mitigation Plan

WHEREAS, the Town of Groveland established a local planning team to work with and assist the Merrimack Valley Planning Commission in the preparation of the Groveland components of the multi-jurisdictional *Merrimack Valley Region Natural Hazards Pre-Disaster Mitigation Plan* (hereinafter, "Hazard Mitigation Plan"); and

WHEREAS, the Hazard Mitigation Plan identifies potential future activities and projects aimed at mitigating potential adverse impacts from hurricanes, floods, winter storms, and other natural hazards in the Town of Groveland; and

WHEREAS, the Town of Groveland, acting through its municipal departments, boards, and commissions, is committed to implementing these potential mitigation activities and projects as future town funding and personnel resources permit;

NOW, THEREFORE BE IT RESOLVED that the Town of Groveland Board of Selectmen hereby adopts the Groveland components of the regional Hazard Mitigation Plan prepared in collaboration with the Merrimack Valley Planning Commission.

Request to Appoint
