#### **BOARD OF SELECTMEN**

#### **DECEMBER 5, 2011**

Meeting called to order at 6:20 P.M.

#### Minutes

Moved Greaney, seconded Gorski, and it was

**VOTED:** To accept the Minutes of November 21, 2011, as presented.

#### Warrants

Moved Greaney, seconded Gorski, and it was

**VOTED:** To approve Payroll Warrant #12-22.

Due to Selectman Darke's absence, Chairman Gorski called upon the Rule of Necessity for the purpose of approving the payroll Warrant. 2-0

Moved Greaney, seconded Gorski, and it was

**VOTED:** To approve Deduction Warrant #12-20A and Bill Warrant #12-21. 2-0

#### **Property Use Permit**

Selectmen signed Property Use Permits for Council on Agining and Groveland Soccer League. The Board asked their Assistant to contact Soccer representative Steve Merrill and ask him to provide the Board with a list of all neighbors he contacted on Gardner, Main and Wharf Drive noting their approval/dissent of a DJ playing music at Shanahan the night of the Haverhill's fireworks.

#### 6:30 P.M. - Tax Classification Hearing

Assessor Gerry Hill and Office Manager Debra Webster, met with the Board to inform them of the Board of Assessors vote for setting the FY '13 tax rate. Webster, acting as spokesperson for her Board, informed the Selectmen that the Assessors once again voted unanimously to maintain a single tax rate for Commercial and Residential property. Webster also told the Selectmen that values have dropped about \$3,000 per average home and the average increase will be about \$109.00 this year which does not include the Bagnall School override which will appear on the next fiscal year's tax rate. The tax rate for FY 2013 is set at \$12.98 per \$1,000.00.

The Selectmen thanked the Hill and Webster, and upon motion duly made by Greaney, seconded by Gorski, it was unanimously

**VOTED:** To approve the Assessors recommendation for a single

tax rate for fiscal year 2013.

### Resignations-Call Firemen

Call Firemen Shawn Procurot, 16 years on the department, and Lawrence White, almost 8 years on the department, met with the Selectmen and informed the Board that they had recently resigned as call firemen. Sean told the Board that he and Dan Richmond had completed 24 hours of training over four (4) days, gave up two Saturdays and had to leave work early to do so; they were then told by the Chief's Clerk, Jim Jordan, that there was no more money to pay them for their training hours and they were never paid. The Selectmen apologized to Procurot and authorized the Finance Director to submit their training hours for immediate payment. Labrecque responded that he would email the Chief in the morning and inform him of the payment being made.

## MINUTES-PAGE #3 DECEMBER 5, 2011

White told the Board that he had turned in his gear today after 7.5 years on the department and 5 years on the Ipswich Fire Department. White told the Selectmen that things are not the same as when he first joined. White expressed disappointment with the way the recent promotions were made and told the Board he felt he should have been considered for promotion; that he did his job very well and contributed a lot of the department. White was responsible for obtaining a grant for a truck a few years back. White told the Board he thought the promotions would be based on certifications and experience but all names were not brought forward. White did acknowledge that those who received the promotions will do a good job for the department. Procurot agreed that it is no longer the same since he joined and told the Selectmen he no longer enjoys it; that they now make rules up as they go and things aren't taken care of.

The Selectmen thanked the men for their past service and told them they were sorry they were resigning. Chairman Gorski and Selectman Greaney thanked the men for informing them of their concerns and reasons for leaving.

There being no further business to come before the Board, moved Greaney, seconded Gorski, and it was

**VOTED:** To adjourn.
