Meeting called to order at 6:30 P.M.

## **Executive Session**

Moved Darke, seconded Greaney, and it was

VOTED: To enter into Executive Session in accordance with the provisions of MGL Ch. 30A, Sec. 21(a) (3) to conduct contract negotiations

with the Chief of Police.

GREANEY, DARKE - "AYE"

Selectman Darke announced that the Board will return to the Board's Open Session at the close of the Executive Session. The Executive Session was entered at 6:59 P.M. The Minutes of the Executive Session are on file in a separate binder in the Selectmen's Assistant's Office.

Selectmen returned to open session at 6:45 p.m. and upon motion duly made by Greaney, seconded by Darke, it was

VOTED: To renew the Chief's contract for three years effective July 1, 2012 through June 30, 2015, and to reappoint Robert Kirmelewicz as Chief of Police for a three year term effective July 1, 2012 through June 30, 2015.

Chairman Darke told Chief Kirmelewicz he would like Selectman Greaney to serve as the Board's liaison with the Police Department. Kirmelewicz stated he has no problem working with Selectman Greaney, Chairman Darke told the Chief that he would like him to contact Greaney if/when problems crop up in his department and that both Selectmen want him to use town counsel when needed and not to just rely on the Chiefs' counsel. Kirmelewicz responded that he welcomes the opportunity of having a liaison with the Board.

The contract was signed by Chairman Darke, Selectman Greaney and Chief Robert Kirmelewicz, and the Board's Assistant signed as "witness to all signatures". Chief Kirmelewicz thanked the Selectmen for finally getting the contract done and told them he appreciates their support.
