# Cable Committee and Employee

The first show will be about the bridge reconstruction, the trail project that will eventually allow hiking to Newburyport, and an update on Groveland Day. #### **COA Outreach Worker**

## Report from Police Department Liaison

Selectman Greaney reported to his fellow Board members that Deputy Gillen has received notification that he has been accepted to the F.B.I. training classes and will be going to VA in July and completing the training through mid September. Selectman Greaney told the Board that this is an honor for both Deputy Gillen and the Town of Groveland. Greaney also reported he had been told that the federal government requires that the town pay the employee while in training and also provide transportation for him while he is away; that he will be meeting with Lt. Cudmore from Georgetown who had participated in this program several years ago and he will answer any questions the Board might have. Selectman Gorski asked if all of the Deputy's shifts will be covered and Greaney told her they will be.
