# Matters per Agenda

Erin Pinkham, Joe Sullivan and Brian Lynch provided initial plan for removal of playground equipment at Washington Park. Mr. Sullivan has volunteered to donate equipment and labor to accomplish this. He is a licensed contractor. Discussion ensued on details and that Highway Dept may do the work despite the offer. The offer is acceptable to the board and a final decision by parties involved will be made with final approval by Board of Selectmen. The goal is to have a new playground approved, installed with old one removed- by July of 2015.

Presenters were invited back to a meeting with Board of Selectmen on December 12<sup>th</sup> at 6:30- to be duly posted- to make a presentation of formal proposal for removal of old playground and installation of a new one

Beer and Wine License for Gerry's Variety was signed by Board of Selectmen to conform to change request for Sunday operation to 10:00 AM from noon. No vote was needed

Board discuss Inez Steele's proposal to reduce speed limit near center of town on Main street and a letter by Chief Robert Kirmelewicz in support was reviewed and portions read out load. # **PUBLIC COMMENT**

#### Resident Debra Stewart

Presented details of poor conditions of roads and grounds at cemetery and petitioned the board for intervention to improve conditions. Board responded with suggestion to seek a meeting with Cemetery Commission.

## **Resident James Freer**

Presented concerns that Marijuana facility by laws have been drafted along with general zoning modifications as part of a year-long effort and collaboration between ZBA and Planning Board and that it is necessary to immediately engage with town counsel for consent to proceed with changes prior to Town Meeting. Mr. Freerer also strongly urged board to initiate a series of public hearings in anticipation of public hearing requirements prior to seeking changes/ modifications to ZBA code be presented at town meeting.

Board concurred to the urgency of both requests and Chairman Gorksi directed Finance Director Dembkoski to seek advice of counsel with an increment – billing allotment of 5 hours initially

## SELECTMEN'S TIME

Dunn suggested and board consented to each member presenting only one agenda item for future engagement.

- Dunn: Would like to see the position of Road Commissioner change from elected to appointed
- ➤ Gorski: Asked for resolution to concerns expressed with re-organization plan underway with recreation department and implications for youth groups. Response by Finance Director Dembkoski is that the item would be addressed in late year or early next year for recreation organization and further out for youth groups as the matter is complex and requires reflection and multiple planning and collaborative steps .
- ➤ D'Amore: Yemma road rezoning to be deferred until board is ready, however, by contacting Yemma Road property owners and agents a site-walk if possible will be conducted and members of the community who are familiar with the property questioned as part of a fact find in anticipation the item will become an agenda item for the future.
- ➤ D'Amore: Would like to propose a workshop for all Boards, specifically those on the Building Permit Sign-Off Letter, to have a workshop on January 17, 2015 at 9am in the main meeting room of Town Hall. Both Chair Gorski and Selectman Dunn agreed.

Voted unanimously to adjourn the meeting at 8:12pm on a motion by Selectman Dunn and seconded by Selectman D'Amore.
