Alan Fitzpatrick, President of the Rescue Squad explained the need for the change. First Niagara holds both notes with relation to the mortgage and requires payment in January. He stated that the current agreement states that the Town would be making the annual payment of \$280,000.00 in February.

In order to avoid a severe late fee, the Rescue Squad utilized funds set aside for required maintenance, replacement, and upgrades.

The amendment would be either that the Town pass a resolution acceptable to the bank that will allow WTRS to recover our funds, and do so on a yearly basis as this will occur again, or in concert with the bank, Town and WTRS, rewrite the agreement to directly reimburse WTRS for those funds, again, on a recurring yearly basis or some other alternative.

Supervisor Runion stated that the Board could put into the account the \$280,000.00 less what the Rescue Squad already paid and cut a separate check to the Rescue Squad for the amount already paid.

The Town's Comptroller's office would require proof that the specific amount was paid.

He thanked Supervisor Runion, and Town Attorney, Richard Sherwood for their considerable time spent in the negotiation process. He also thanked Tom Quaglieri, "What's Happening Productions" and Nick Viscio, from the High School.

He reviewed some of the benefits of Verizon such as real cable competition, a dedicated government access channel from the High School and Town Hall and dedicated fiber cable running right to the home. Five percent of the revenue will come to the Town of Guilderland.

Councilman Grimm asked what Verizon would be bringing in.

Mr. Hillstrom stated that they already offered phone and internet; Verizon needed an agreement for cable t.v. service.

The agreement called for a 5-year build - out based on density.

This was exclusive of the Village of Altamont.
