This will be the first application for Hadley's new quota of licenses. The Select Board will be asked to approve the application, subject to any order of conditions imposed by the Planning Board.

7:15 pm: Jo-Ann Konieczny: Leverett School PTO - Application for One Day Special Permit to sell/serve wine & malt - 06.07.2014, 6:30pm - 8:00pm at 181 River Drive, Outdoor Pavilion. A special license is required to serve alcoholic beverages during the event.

7:20 pm: Shiki Asian Fusion: Application for Entertainment License & request for prorated license fee. (Annual license fee is \$100.00, prorated amount for 7 months is \$58.31). The Select Board will be asked to grant the licenses for live music and theater and to pro-rate the fee.

7:25pm: Town Accountant – discussion of VADAR revenue reporting

7:30pm: Tom Geryk, Central Hampshire County Veterans Services –application for Civil War Preservation Grant. The scope of work includes restoration of historical materials and a painting of General Hooker at the library. The Library will supply the 50% cash match.

Old Business

- 1. Discussion of Debt Exclusion Ballot Question Radio Equipment for Police/Fire Communication Center. The Police and Fire department will present information on the need for upgrading communications.
- 2. Sealer of Weights and Measures and Fees. The Select Board will be asked to set fees and sign an intermunicipal contract for a Sealer of Weights and Measures to be paid for out of a revolving fund.
- 3. Capital Planning Process. The Town Administrator will discuss a proposal to change the calendar by which the five-year capital plan is compiled.

- 5. Departmental Administration and Finance Policies and Procedures annual update. The Select Board will be asked to ratify the approved operating procedures for departments.

- 7. Water Master Plan contracts. The Select Board will be asked to sign contracts to update the 2003 Water Master Plan. The project was approved by town meeting.
- 8. Sign Warrant for June 19, 2014 Special Election for debt exclusion. The Town Clerk asks the Select Board to sign the election warrant for the special election for June 19, 2014. Five debt exclusion questions appear on the warrant.
