Returns of Fund Balances to the General Fund.

At the Tri-Board meeting of March 4, 2015, the Finance Committee and the Select Board agreed to review fund balances to see if any could be placed on the Annual Town Meeting warrant to be closed and the money returned to the General Fund.

I reviewed the account balances (see attached), and many of the accounts that contain balances can be released by Select Board (not town meeting) vote. In addition, some of the balances will revert automatically to the General Fund on June 30, 2015. Here is a description:
