The Select Board will hold a public hearing as per the provisions of MGL Chapter 61A, Section 14 to exercise the Town's right of first refusal on approximately 9 acres of land located at the intersection of River Drive and Stockbridge Road (Assessors Map 12A, Parcel 19). The land is being taken out of protected agricultural land and is being offered for sale. The Town has the right of first refusal and may exercise that right after a public hearing and within 120 days of the notice of intention to sell. The notice was received by Town Hall on May 18, 2017.

The Town has started a soil evaluation to assess the suitability of the property for development of a municipal building (or buildings), including a fire substation.
