The Select Board has scheduled an "All-Boards Meeting" for Wednesday, January 18, 2017 at 7:00 p.m. at Hopkins Academy to help prepare for the FY 2018 budget.

The goal of the meeting is (1) to communicate clearly how the Select Board identified their priorities, and (2) to coordinate a Town-wide effort to support the priorities.

The Select Board will discuss their priorities, which include:

- Augmenting fire prevention and fire protection services. The Board is exploring adding up to four paid firefighters to the force to ensure better responses to fire-related emergencies.
- Exploring ways to enhance the Town's information technology capabilities as well as strengthening human resources functions.
 - Exploring the creation of a finance director position (either full-time or shared with another town/district). Such a position would be instrumental in ensuring that the tax payers' money is best managed, as well as preparing reports and developing program budgets.
 - Promoting economic development to attract new businesses, improving our business-friendly environment, and keeping existing businesses going strong.

At least one representative of each committee and department should attend this meeting. That representative should be prepared to discuss how their particular department may support each priority or conversely, may be affected by each priority. No formal presentation by department is expected.
