TOWN OF HADLEY, MASSACHUSETTS SELECT BOARD CONSENT AGENDA

Items on a Consent Agenda are exceptions to the general process of the Select Board's Meeting. The Select Board identifies those business items that they believe should generate no controversy and can be properly voted without debate. These items are put on the Consent Agenda to allow motions under these items to be acted upon as one unit and to be passed without debate.

At the call of the Consent Agenda, the Chair of the Select Board will read out the business items, one by one. If one or more Select Board members object to any particular item being included in the Consent Agenda, they say "hold" in a loud voice when the item is called. The item will be removed automatically from the Consent Agenda and voted separately under the usual manner. After the calling of the individual items in the Consent Agenda, the Chair will ask for a motion that the Select Board pass all items remaining <u>AS A UNIT</u> on one vote. Use of the Consent Agenda process makes the Select Board Meeting more efficient by speeding up the handling of non-controversial items.

In February of 2018, WS Development/Mountain Farms Mall received site plan approval from the Hadley Planning Board for an outparcel development project at Mountain Farms Mall to demolish the vacant buildings previously occupied by Burger King and Florence Bank in favor of constructing (2) new buildings totaling approximately 25,000 sf. As part of the site plan approval application, a traffic study was completed by Ron Muller & Associates, which provided suggested recommendations for the re-striping of South Maple Street and modified turning movements to/from Mountain Farms Mall and South Maple Street. The Hadley Planning Board recommended that these recommendations ne "Peer Reviewed" by an engineer of their chosing, Fuss & O'Neill, and together our engineer & the Town's engineer agreed that the attached re-striping plan was the best option in creating the safest roadway condition. This proposed plan will provide a refuge area for vehicles making left turns into and out of the driveways along South Maple Street. This will also improve vehicular and bicycle safety by reducing speeds and providing wider shoulders, and reduce traffic delays at the Mountain Farms Mall and Hampshire Mall driveways. All proposed signing and striping are in compliance with the MUTCD. WS Development will defer to the DPW Director, Marlo Warner, on how he would like them to remove the existing striping, but their preference would be to buff or black out the existing striping. All restriping will be paid for by WS Development/Mountain Farms Mall.
