

TOWN OF HADLEY SELECT BOARD October 3, 2012 Meeting Minutes

Meeting convened at 7:00 pm, Room 203, Hadley Town Hall

<u>Call to Order</u>: Meeting called to order at 7:00 pm by Acting Chair Joyce Chunglo.

Appointment

7:05: Chief of Police, Dennis Hukowicz

- Narrow Band Communications: There is a federal mandate regarding police radios being in line with Narrow Band. Chief Hukowicz stated that they are all set and ready to go, there is nothing left to do. He also mentioned that there is some money left in the warrant.
- Staffing: Currently the department is operating with 4 part time officers and 4 specials. He is currently reviewing special as he has received- he is looking for experienced officers. The Board stated that they would like to expedite the process of hiring in order to cut down on overtime expense.
- Community Policing: Chief Hukowicz stated that there have been break ins in Town and the Chief encouraged citizens to lock their doors, call the police if they see anything suspicious in their neighborhood, and know that unoccupied houses are prey as the burglars are looking for metal (piping) in homes. Discussion ensued regarding community policing/neighborhood watch. It takes strong involvement on the part of the citizens to have this type of program.

7:25: TV-5 On demand video broadcast

Richard Trueswell, TV – Access Coordinator, stated that he would like to provide Select Board and other Town meetings "on demand" on the Town website...the vehicle would be via Internet Site "You Tube." This would benefit citizens who don't get the local access channel. Discussion ensued regarding putting the entire meeting or just certain meeting segments. *Brian West made a motion, seconded by David Moskin, to approve a 3 month pilot program featuring unedited meetings, and revisiting the matter after the first of the year. Motion passed by a vote of 4-0-0.*

2. Veterans' Officer Position

The Board reviewed proposals/applications for Veterans' Service Officer to cover legal obligations of the Town for its Veterans. Discussion ensued regarding whether to go with a district wide program versus an individual, and how to recruit an appropriate candidate from Hadley. Brian West suggested tabling this matter, publicizing the position as a part time position, and then make a decision in two weeks. Joyce Chunglo stressed that a job description is needed to define the qualifications necessary for the job.

7:35: Todd Ford: Hampshire Council of Government – Annual Visit

Todd Ford, Executive Director and Mike Sarsynski from Hampshire Council of Government discussed the services that the organization provides. Some of the programs include a purchasing co-op, IT

1. Chapter 61A – Waskiewicz – Release of lien

Brian West made a motion to take this under advisement, seconded by Dan Dudkiewicz and passed with a vote of 3-0-0. The Board would like to investigate all options regarding this land.

2. Capital Plan proposal

Mr. Nixon presented the Board with two borrowing proposals for capital upgrades, one at 0.5% and one for 2.5%. Both plans are within the Town's threshold and can address many capital needs. This information is for review and can be discussed at a separate meeting. Dan Dudkiewicz suggested having a meeting dedicated solely to this item.

- 4. Hadley Mothers' Club permission to hang sign on Russell Street School fence.

Request for Special One Day Permit to serve Wine/Beer 10/07/2012: 5:00 pm-8:00 pm

Brian West made a motion to allow a one day license, seconded by Joyce Chunglo. Chief Hukowicz stated that he had no problem with the event/license. Dan Dudkiewicz stated that he was opposed due to the farm location being in a residential area. Motion passed by a vote of 2-1-0.
