### **MEETING OF MAY 08, 2012, 6:30 PM**

## 1. APPROVE MINUTES OF MEETING OF APRIL 10, 2012

Motion by John Shiavone, second Tom Millias to approve the minutes as written. Vote unanimous.

### 2. DISCUSS ATM/STM TOWN WARRANT

Discussed Warrant for ATM on Monday, May 14, 2012. Assessors have Article 25 regarding final appropriation for FY 2014 Triennial Revaluation. Article 50 regarding Authority to Negotiate a Solar PILOT will make the Assessors the designee in that Authority. Article 48 regarding Town Liens & Charges would involve the Assessors by including such charges on the Real Estate Tax Bills.

Article 2 of the STM regarding a town vehicle for town employee use would be beneficial to the Assessing Department for conducting the town-wide measure & list project as well as permit inspections.

# 3. DISCUSS REQUEST BY TOWN ACCOUNTANT/FINCOM TO RELEASE \$176,743 FROM OVERLAY SURPLUS FOR USE AS AN AVAILABLE FUND AT ATM

# 4. DISCUSS FY 13 INTERIM ADJUSTMENT OF ASSESSMENTS

Sue Duggan advised the Board that the Town Value will drop by approximately 5% overall. Land values will drop by 50% and single family homes by approximately 3%.

# 5. DISCUSS ANTICIPATED USE OF A TOWN VEHICLE FOR THE MEASURE & LIST PROJECT

The Board discussed scheduling of the town vehicle should Article 48 of the ATM pass. The vehicle would, most likely, be used by the Assessors, Health Agent & Conservation Agent. Tom Millias will be responsible for scheduling its use.
