## **Open 7:00 – NOI – Corner of Pine and Bow Sts.**

Al Vautrinot was present to discuss the plans for new home construction. This is a lot that had the septic designed about 6 or 8 years ago. The Wetlands was determined back when Alan Dias put Pine St. in. They are proposing a house, septic system and a little grading within the 100' buffer. There will be no work within the 50' buffer. They didn't even design a siltation barrier as there is a gutter along the road which will act as a barrier. Al believes that it is BOH approved already.
