Capital Plan

We have \$1,165,938.00 in Free Cash plus \$70,000.00 in Meals Tax money to spend on Capital Items this year.

They would like to rehab Engine 1 until a large truck is purchased. This it will move to a second line vehicle.

Gas tank replacement is a State mandate.

Cab over truck is replacing the cemetery truck. Cemetery funds will be used.

Paying off the water tower debt from the water retained earnings. They would like to purchase a swap shed and a compactor also with the retained earnings.

General Budget Updates

HES did not meet. They will be meeting on 3/21/18. Rumor has it that they were cutting \$117,000.00 from the budget that they had presented. Gordon believes that does not include the \$34,000.00. Silver Lake number should be about \$175,000.00.

Charlie suggested that the Committee take the 2018 budget and make changes. He came up with .5% across the board including the school. Schools would have to absorb the other 1.5% within their budget. He is not suggesting cutting 2 hours in each department, but we can save money elsewhere.

Mel Conroy made a motion to have the Wage and Personnel board provide the research

information they have gathered on the 10 Benchmark Towns. Seconded by Melinda Tarsi. Motion passed unanimously.
Sandy Nolan left the Tax Title line as an increase for now.
It would be approximately \$98,000.00 to provide a 2% pay increase for union, non-union and elected officials for the FY19 Budget.
