## Reserve Fund Transfer

A Reserve Fund Transfer was received from Pamela Adduci for $\$ 5,000.00$ to pay for legal fees for 15 parcels in foreclosure.

Mel Conroy made a motion to approve the Reserve Fund Transfer. Seconded by Melinda Tarsi. Motion passed unanimously.

## Meeting Minutes

Diane Ruxton made a motion to approve the Meeting Minutes from $2 / 12 / 18$. Seconded by Melinda Tarsi. Mel Conroy abstained. All other members in attendance voted in favor of approving the minutes. Motion passed.

Wage and Personnel
The totals for the four positions that they are asking to increase are as follows:

Health Inspector: \$1,614.00 increase yearly
Building Inspector: $\$ 1,781.00$ increase yearly
Water Superintendent: \$2,185.00 increase yearly
Recycling Coordinator: $\$ 1,373.00$ increase yearly and a new job title
Total Increases are $\$ 6,953.00$ for the 4 positions added together.
Article 4
Line 30 - Mel Conroy made a motion to reconsider. Seconded by Melinda Tarsi. Motion passed unanimously.
Mel Conroy made a motion to recommend $\$ 16,426.00$ for Elect/Register. Seconded by Melinda Tarsi. Motion passed unanimously.

Schools
There is talk about having a school resource officer at HES. Approximately $\$ 70-\$ 75 \mathrm{~K}$ is the salary that they are expecting to have to pay if that actually comes to light.

Joy Blackwood asked if the Town would be capable to pay the $\$ 175,000.00$ that they have arrived at so far if we chose to support the budget. Mel replied that there are dollars available; however they are very concerned with the growth rate. Increase is $2.67 \%$ and Kingston has voted to support their assessment. Silver Lake is the largest employer of the three towns. It is like its own city. They feel that this is a reasonable budget without shorting the kids. It is not a luxurious budget. They had 5 positions retire which gave them some flexibility to rearrange the budget. They are trying to put in a few new programs that will entice kids to stay in district and therefore we don't lose them to Charter Schools. That has been a huge impact to their budget. All of the schools are interested in having a school resource officer. Kingston provides the resource officer $1 / 2$ time at the SL campus. Halifax and Plympton do not provide any support for that. They would love to make that full time if possible. The Capital Plan is being funded out of E\&D again this year. They are doing their best to be self-sufficient by being fiscally responsible. They will let us know when the E\&D is no longer covering the larger items. They will continue to prioritize the Capital Plan accordingly and will be building out more than a 5 year plan. Every year, at least $\$ 200,000.00$ is committed to repairing the items on the building that need to be taken care of in order to try to stay on top of it.
