#### Liaison Updates

Ambulance receipts have current projections of \$176,000.00 which is going to fall a little short of our \$416,000.00 target. Sandy Nolan believes that we will end up coming out close to even in the end.

Local receipts are a little above where they were last year. District Court fees are low, which is strange, but Sandy is keeping her eye on all of the numbers each month.

The Library met with Diane and gave her some paperwork outlining what they need to do to meet the guidelines to be accredited. \$320,761.00 is the number that they need to get to. She does have some Capital items that can come out of her budget to make up for the wage decrease and help to get to that number. Further discussion is needed.

Stu spoke with Bob Badore and his Operating Budget is level funded so he thinks Highway should be pretty straight forward. As far as Capital Items, that is a different story, so we may need to have him come in to discuss Capital.

### School Building Project

The total of both Articles will be \$7.95 Million. Both will be debt exclusion. Fire suppression and sprinklers in one Article and everything else will be in another. We will

be receiving \$3,472,000.00 back from the State in funding and will bond out the rest. It will mean approximately \$150.00 on the average tax bill. It is a 56.2% rate on the reimbursable items. (windows, doors, etc.). There will be an informational meeting on 2/15/17, Special Town Meeting on 3/7/17 at 7:30pm and Town Election on 3/11/17.
