Special Town Meeting

<u>Article 1</u> – Transfer \$210,000.00 to Line 54 Fire Wages for a total of \$817.250.00. Mel would like to see the revenue numbers higher, more toward \$230,000.00 in order to earn his vote. He is concerned about a valley. The chief explained that the billing is actually further behind than just 3 months so the money is till coming in. Gordon shares Mel's concerns. If the Article passes, it would take effect immediately. If he had to make a cut it would be to the night coverage. He will need to look at the numbers again in the December/January time frame to be sure everything is still on track.

Mel Conroy made a motion to recommend. Seconded by Linda Braga. Motion passed unanimously.

Article 2 – Dispatchers Contract. No progress has been made at this time.

<u>Article 3</u> – Will create a new budget line for the Dispatchers Wages to be paid out of. Housekeeping item.

<u>Article 4</u> – MSBA grant at HES will need \$140,000.00 for Project Manager, site survey etc. Work includes 40 windows, 90,000 sq. ft. of roof, façade, drainage system, etc. Any extra money will require another Town Meeting to move the money from Stabilization.

Mel Conroy made a motion to recommend. Seconded by Linda Braga. Motion passed unanimously.

<u>Article 5</u> – Monponsett Pond Management Placeholder. May be passed over at Town Meeting.

<u>Article 6</u> – HOPS Placeholder. May be passed over at Town Meeting as they are not ready yet.

### Meeting Minutes

Mel Conroy made a motion to approve the Meeting Minutes from 6/27/16. Seconded by Linda Braga. Motion passed unanimously.

### Update on Letter to Legislature

Kingston has not voted so there is no contract. Therefore, Rep Calter cannot do anything. He does not have discretion to file special legislation yet as there is no binding contract. It must be approved in the House and Senate. Rep Calter is in favor of letting all 3 towns vote on the matter.

<u>Monponsett Pond signs</u> They are being worked on. They are in the design process.
