Treasurer/Collector

Line 30 increase is due to steps, and extra day and 3 floating holidays for the current staff. Line 31 includes classes for the new positions, an increase of \$500.00 for postage, and an increase of \$2,500.00 for office supplies. Kathy will provide a breakdown.

Gordon has a meeting with John Tuffy tomorrow to discuss the spreadsheet that he and Mary McKinnon made. The towns still own the Pembroke Retirement money as well. Gordon feels the Regional Schools should have applied for a waiver for the onetime \$335,000.00 revenue as it would affect the minimum contribution. \$4,164,071.85 is Silver Lake's request for Halifax for the Operating Assessment (not including debt). There is an increase in insurance, retirement, steps lanes, audio visual (software, not new). Capital items have been removed from the Operating Budget but still need to be funded. The Committee will further discuss the number the Cassey is looking for on Monday after Gordon has met with John Tuffy.
