Meeting called to order by Gordon Andrews at 7:11pm. Meeting is being taped by CHAT TV.

Mail

A letter was received stating that the Vocational number had increased by \$27,000.00 to \$159,000.00.

Reserve Fund Transfer

A Reserve Fund Transfer was received from Charlie Seelig for \$15,000.00 to the Veteran's Benefits Line.

A motion to approve the Reserve Fund Transfer was made by Peg Fitzgerald, Seconded by Julianne Crawford. Motion passed unanimously.

Data Processing

The Elementary School did not fund $\frac{1}{2}$ of a person as planned. The position was graded at a Grade 7 with Wage and Personnel. Julianne questioned whether a Coop or internship would be an option to potentially save some money. The line will be changed to a PT position at \$20,000.00. The first priority will be Town buildings with sharing with the school still a remote possibility. Total amount will be \$70,760.00.

Town Clerk

Statutory Offices needs to be manned while Town Hall is open. The Clerk is responsible for records, elections, voter registrations, burials and town meetings.

Collector / Treasurer

See handout given for explanation of expense line. FY14 they had 24,322 pieces of mail @ \$10,049.14 for a total cost of postage. FY15 they have already spent \$2,998.93 on supplies. Kathy Shiavone felt that if totally necessary she could cut approximately \$1,000.00 out of her budget this year.

Vocational Ed

An additional Student will be attending so the cost has increased to \$159,000.00.

Silver Lake Assessment

\$4,127,189.00 is the recommended amount for the assessment this year including the amount for the Capital Plan items coming out of E&D. Peg feels that we have no choice; we can express whatever outrage we want, however, we can afford it and that is our job. Julianne asked what happens if the assessment does not get approved at town meeting. Gordon explained that Kingston and Plympton have not formally given an opinion that we know of. He also explained that this is not a 3 town Finance Committee. Peg was curious if this is a joint venture with all 3 towns. Her responsibility is to Halifax; however she would entertain listening to the other towns because you never know when you need a favor. However, we need to remember that a blended feeling may not be in the best interest of everyone.

Board of Health

Wage and Personnel has denied the position so they have changed their request to a level funded Health Expense line. Cathy Drinan would like to still pursue the Agent that she was unable to find last year. Gordon will get info on the Inspector of Animals from the Board of Health for the next meeting.

Building Inspector Wages

Wages were at \$63,669.00 including \$250.00 in longevity. They were cut to \$55,074.00 which is a decrease of \$8,500.00

Wage Increase

A 1.5% Wage Increase would mean \$69,250.00 overall and would include all Wage and Personnel employees, elected officials and wage openers. It can't be funded without touching the school budgets so everyone is hoping that something happens between now and Town Meeting to change that.
