There is no free cash number yet and not much overlay available. There is only about \$50,000. Leftover from last year. We are still waiting for tax title #'s to come in. The Auditors have not bee in to do the closing yet but we are hoping for a figure before the New Year.

Senior Center

Nothing new that Charlie has heard of. Peg was approached for advice on a Special Town Meeting on the subject. She felt it should to the Annual Town Meeting instead as younger people should be involved in the decision.

Meal Tax

The Meal Tax would increase by .75% so it would go from 6.25% to 7%. It would go to the State first and the state would send the check back to the town for the excess. Business owners would feel that their business would suffer if the taxes were increased. Charlie will research what other towns are participating but he is pretty sure Middleboro, Bridgewater, West Bridgewater, Pembroke, Carver and Kingston are among them. The extra meal tax would have created \$73,000.00 in 2014.

Spending

Building Maintenance is getting close on their budget. They had some things come up. They still have their previous budget so that is good but Sandy is keeping an eye on it.
