Line Item Transfer

A Line Item Transfer was received from Acting Fire Chief Jeff Cuozzo to transfer \$3,500.00 from Fire Training to Vehicle Maintenance.

A motion to approve the Line Item Transfer was made by Peg Fitzgerald. Seconded by Nikki Newton. Motion passed unanimously.

A Line Item Transfer was received from Acting Fire Chief Jeff Cuozzo to transfer \$7,000.00 from Fire Training to Fire Chief Salary.

A Line Item Transfer was received from Acting Fire Chief Jeff Cuozzo to transfer \$2,000.00 from Fire Training to Ambulance Supplies.

Budget Items

Repair of the Metal siding is needed on the Recycling Center Main Building. They have a quote of \$16,600.00 and would like to amend their expense line on Town Meeting floor to include this amount. It would be a onetime increase and next year their expense line would go back to level funded. Stu would like to see things like this in a Capital Plan in the future.

Line 111 – Peg Fitzgerald made a motion to reconsider the line. Seconded by Karen Fava. Motion passed unanimously. Peg Fitzgerald made a motion to recommend \$37,685.00. Seconded by Summer Schmaling. Karen Fava voted no, all other members present voted yes. Motion passed.

Stretch Code

Tom Millias and Seth Pickering came to discuss the Stretch Code. There will be a new base code that will be effective as of July 1, 2014. The energy code that is coming in will be applicable if the stretch code is in your town or not. There is a very small difference between the two. Most differences will be with new construction. You will need to hire a HERZ rater and a computer analysis would also be submitted with the permit application. The costs to the residents would increase in that area. The difference between the Stretch Code and the new Energy Code is that the Stretch Code looks at the entire energy consumption. The HERZ rater does an actual physical inspection in addition to those that the Building Inspector does. Renovations would need a permit, but only the part within the scope of the permit would be subject to the Stretch Code. After the 5 criteria are met, the town can get free audits and qualify for a free energy comp. program that is supplied by the Mass. DOER. It would require that the town have someone that can apply for the grants that are available and the town may be encouraged to form an Energy Committee. Mr. Millias is in favor of the Stretch Code.
