Mail

Two memos from the Selectmen were read stating that they have received the resignation of both Peter Beals and Paul Weckbacher from the Fin Comm. effective immediately.

A Budget Status report was received from the Asst. Accountant as of 12/31/12.

A letter was received from the Asst. Treasurer re: the Health Insurance Budget line. She would like to adjust it to the new figure of \$881,427.56. This is a decrease in what was initially submitted as it was expected that the fund would see an 8% increase and in fact the worst case scenario is a 2% increase.

A full copy of the FY12 Audit was received and will be kept in the Fin Comm. files.

A new copy of the Beacon was received.

Reserve Fund Transfers

A Reserve Fund Transfer was submitted by Bob Badore in the amount of \$10,000.00 to the Equipment Account. He is down to \$2,000.00 in that account with 2 months of winter left. This money should cover the repairs that will be needed for the rest of the season baring any major issues. Peg and Stu will obtain copies of the invoices, receipts etc and will revisit at the 3/4/13 meeting.

<u>Budget Updates</u> Peg will follow up with the Comm. Center.

Lisa Gilbert said that there were no new updates for HES. They will be meeting on March 4, 2013

Cassey Hanson said there were no changes from the 14th at SL. There will be Health Insurance savings that will be reflected on the next budget that is released. Sequestering will affect us as well. If you take away the Federal money you many need to adjust local aid to make up for it. The Schools are more vulnerable due to these grants.

If the Library does not stand by their agreement from previous years then we will reconsider their budget and level fund it. Gordon expressed concern that we treat the Library differently than all the other depts. and that has to change. Peg said that they have in past years turned over excess money to the town. Nikki stated that Jean Gallant told her they were not willing to hold to that agreement this year. Last year because of the wage increase the expense budget was adjusted down so the salary budget could go up to keep the bottom line the same. FY14 was approved because that deal was going to be the same. Certification is in question but they will have to go for a waiver from the state if the agreement is not going to hold.
