Mail

No mail was received.

Reserve Fund Transfer

A Reserve Fund Transfer request was received from Kathy Shiavone, Treasurer/Collector for \$1,500.00 to Collector's Expense Account. There is currently \$5.02 in the account due to the increase in postage and the number of mailings. That is not going to be enough to cover the water bills that will need to be mailed out. Cost will be reimbursed by the Water Dept. The Committee would like more supporting documentation. Stu asked if there are rules against "pre-paying" on accounts. Sandy stated that it is a postage meter account so it is allowed.

Nikki Newton made a motion to have Kendra send a memo asking for the current balance in the Pitney Bowes Account and for any other expenses other than those related to the Water Dept. mailings. Seconded by Peg Fitzgerald. Motion passed unanimously.

Veteran's Agent Discussion

Peg went to the Wage and Personnel meeting on Tuesday night. They felt that the \$16,702.00 that was previously recommended was too high for the position. They surveyed 10 comparable towns along with the surrounding towns and that number was higher than any of them. They are recommending \$13,557.00 for the combined position.

Cable Committee Discussion

75% of the subscribers are currently from Halifax with 25% being from Plympton. Even though Plympton only has 25% of the subscribers, they are planning to contribute

\$10,000.00 to the non-profit start up. The old license was under Adelphia and then was taken over by Comcast. Comcast no longer wants to run the studios. We must either set up a non-profit or a new Town department to run it. If they get 501C3 status, they can be eligible to receive Government money, contributions and grants. That money is not taxed and they can also use the funds to provide the product. It will be a Free/Independent Community based service. This is not an ongoing fund request. They are in hopes to get 5% of the Cable TV fees from Comcast for Plympton and Halifax for funds. Nikki asked if online streaming would be in the future and the answer was absolutely. Resources would be transferrable to allow for MP4 streaming. Peg asked what benefit this would have to the town as people should be coming to the meetings, not just watching them on TV. Right now Comcast is required to provide public access. The Federal Law (PEG) requires them to provide Public Access. We have 3 choices as a town at this point. 1) Run the public Access studio as a Town Department. 2) Join a larger group of communities like Plymouth to provide Public Access. 3) Join a small group with Plympton. We need to get the Town out of the business due to liability. A non-profit group can sensor the material submitted, the town can't. Peg asked if there would be salaries involved. If so, the Comcast fee would cover that cost. Only consulting fees would be coming from the money if the town votes to appropriate it. Stu asked if there was a mission statement created for the non-profit. Mr. Bennett read the initial draft as it stands right now. As a non-profit, is there intent to do some fundraising in town? Yes, if there is a need. (It will be used for additional expenses for production, training etc.)

Quorum Discussion

Finance Committee is a 7 member board. In the bylaws, it states that Quorum is 4 members. That number does not change if seats become vacant. The Committee wishes to make a change to the number of votes needed for a vote to pass.

If there are 7 members of the board, 4 yes votes would be needed.

If there are 6 members of the board, 4 yes votes would be needed.

If there are 5 members of the board, 3 yes votes would be needed.

If there are 4 members of the board, 3 yes votes would be needed.
