2. 7:15 – 8:30: Disposal Works Permits

a. 334 Thompson Street – Request for approval

b. 2 Danson Lane: Is up for renewal of permit for being approved more than three years ago. At the last meeting you requested Agent review the comments on the plan. Engineer sent copy of original letter, requesting a field/bed configuration instead of trenches because it is impossible to dig trenches in loose sand. (At the time, chambers over existing soil were not often being proposed.) In 2005 several of these field SAS's were approved. Do you want to continue that approval or require chambers?

3. Requiring Variances (but otherwise recommended for approval):

- a. 7:15 27 Lantern Ln: Bob Crowell will be bringing in a plan with buoyancy calcs, three local upgrades and three variances. Currently, it is missing a request to vary from 15.227.5, reduction inverts to high groundwater. It depends on which high ground water is used and even with the higher of the two, the pump chamber outlet invert is 52.75 and hgw is 52 at the pond and 53.4 for the perched water.
- **b.** Rubber membrane is in a place for continuation of perched water
- **c.** Please decide on high groundwater issue. I agree the higher level was perched on peat material and that the water drained down very quickly into

the sands and loamy sands below it. I do not know if the R&R and membrane are sufficient for a system at the bottom of a hill. Any guidance on that?

- i. In attendance Bob Crowell, Design Engineer, Tim Feely, Owner. Engineers updated the Board on new plan.
 - **1.** System is within 50' of a pond. Needs DPH approval.
 - **a.** Engineer to re-do plan. Re-visit at August 19, 2009 meeting.

d. 33 Beechwood Road

- **i.** Variance for reduction to high ground water (4' to 2')
- **ii.** Also, they proposed retaining the 1,000 gal tank. In the past you have required upgrading to 1,000. Vote to approve with that condition?
