Halifax Board of Health Meeting Minutes Wednesday, July 17, 2013

On Wednesday, a meeting of the Halifax Board of Health was held in the Board of Health office at 7:00 p.m.

3. Appointments:

- **a. 7:30pm:** Barton Bruffee Title V Inspector requesting Title V permit renewal.
 - i. The Board asked Mr. Bruffee to describe what he has done to improve his Title V report inspection process. Mr. Bruffee stated he has worked with Bob Filbert in Bridgewater and East Bridgewater to improve the way he does his inspections and his reports. He brought in a copy of his license and certificates to two classes he attended, NEWIER-Continuing Education and University of RI – Waste Water On-Site Training Center.
 - 1. The Board requested that Mr. Bruffee submit copies of at least three (3) title v inspection reports he has completed and submitted to the Bridgewater Board of Health and they will review the inspection reports and make a decision as to the renewal of his Title V inspector's permit in the town of Halifax.
- **b. 8:00pm:** Dog Grooming Salon Business at 590 Monponsett Street Diana Dinatale was in attendance.
 - Ms. Dinatale informed the Board of her desire to open a dog grooming salon. She discussed several locations including 590 Monponsett Street and 300 Plymouth Street. The Board informed Ms. Dinatale that an engineered design plan would be required. Ms.

Dinatale disagreed and stated she didn't understand why when there was already a system in place. The Board explained that the system currently there was designed for the previous establishment and a new engineered design or review plan will need to be done to show that the system can handle the water flow of the new business going in. Ms. Dinatale was not pleased with the Board stating that a design engineer would need to be hired and a plan submitted before they could approve a dog grooming business and adamantly disagreed. The Board told Ms. Dinatale that is what is needed in order for her to move forward with her business plan and that the Board of Health was not going to take on the liability of approving something they don't know will work. Ms. Dinatale told the Board they were not listening to her and the Board rebutted that she was not hearing what they were trying to tell her. The chairman stated, for example, if the existing system was designed for a dress store or tax office then that is what the engineer at the time designed the capacity of systems water flow for. A new engineered plan or review of the current one needs to be done to prove that the current system can handle the water flow of the dog grooming salon, or present a new design plan for a system that will. The Health Agent stated the use is very different. The use has to do with what's in the water in addition to how much water is used and Board agreed. Ms. Dinatale was not happy and stated she certainly was not going to hire an engineer and that she would not be doing business in Halifax.
